	<b>4.3 Indication of any immediate medical attention and special treatment needed</b> In the case of burns do not remove the wax from the skin, it will provide an airtight sterile covering, which will eventually fall away with the scab as the burn heals. If removal is attempted mineral oil (not mineral spirits) or a mineral oil based ointment may be applied to help soften the product.
